

Check Writing Request Form

WHEN TO USE THIS FORM

The Check Writing Request Form is used to set up check writing capabilities, request checks or cancel check writing on a taxable account.

Instructions and Guidelines:

Complete all of the required information and submit the form by one of the options listed below. The Signature Card must contain the following information:

- Account Registration Provide the registration name as it appears on your ETC Brokerage Services Statement
- Name/Title Provide each authorized signers name
- Signature Each authorized signer on the account needs to sign the Signature Card
- Date Provide the date for each signature

Please allow 25 days to receive your checks.

Note:

- · You cannot cash checks at Dollar Bank or use checks to make an investment purchase from your account.
- You cannot make a direct deposit to the bank and account number on your checks. Please contact ETC Brokerage Services or your Financial Representative for deposit instructions.
- Required Minimum Account Balance \$500. Checks issued that will result in an amount less than the minimum required balance will not be paid.

Fees:

\$100 to establish check writing on your taxable account. (Includes first 40 checks)

\$65 for additional orders of 40 checks

\$20 Regular Mail and Taxes

\$30 2-Day Delivery and Taxes

\$166 Expedited Printing, 1-Day Overnight Delivery and Taxes

*All fees will be debited from your account.

ETC Brokerage is not responsible for any market impact, fees or other consequences you may incur as a result of our liquidation of assets to cover a check remitted by you. ETC Brokerage also reserves the right to cancel the check writing capability on your account, at its discretion for anytime and for any reason.
