Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.		
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:		
	 Social Security number and account transactions Account balances and transaction history Assets and investment experience 		
	When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.		
How?	All financial companies need to share customers personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers personal information; the reasons ETC Brokerage Services chooses to share; and whether you can limit this sharing.

Who is providing this notice?	ETC Brokerage Services, LLC
What we do	
How does ETC Brokerage Services protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does ETC Brokerage Services collect my personal information?	We collect your personal information, for example, when you: Open an account or direct us to buy or sell securities Make deposits or withdrawals from your account
	 Provide account information or give us your contact information We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only: sharing for affiliates' everyday business purposes—information about your creditworthiness affiliates from using your information to market to you sharing for non-affiliates to market to you
	State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state laws.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.
	Our affiliates include financial companies, such as Equity Trust Company, Equity Advisor Solutions, LLC, Equity Administrative Services, Inc., Investors United Title Corporation, Equity National Lending, LLC, and Equity Real Estate Services, LLC; and nonfinancial companies, such as Retirement Education Group, Inc. d/b/a Equity University.
Non-Affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
	■ ETC Brokerage Services does not share with non-affiliates so they can market to you.
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.
	■ ETC Brokerage Services does not jointly market.
Other Important Information	California Residents: We will not share your personal information with nonaffiliates for their marketing purposes without your authorization. We will not share your personal information with affiliates or with other financial companies for joint marketing purposes. Vermont residents: We will not share your personal information with nonaffiliates for their marketing purposes, or share consumer report information about you with affiliates, without your authorization.
